CITY LOOKING FOR RECIPIENTS OF CENTENNIAL LETTERS

ROCKPORT, TX – Fifty years ago residents were given the opportunity to write a letter during the City of Rockport and Aransas County's joint centennial event and place it in a time capsule to be opened at the 2020 Sesquicentennial (150th) Anniversary. This time capsule was unearthed from its burial place prior to the demolition of City Hall in 2019 and taken to the Service Center. The capsule was a stainless-steel tube, approximately 48 inches high and 18 inches in diameter and was placed inside a concrete vault.

Despite the lid being tightly fastened and no apparent means for water intrusion, most of the contents were wet and there was an accumulation of water at the bottom, likely from condensation. Due to the moisture, many of the items were dirty, rusted, and generally in poor condition; however, many items did survive.

Among them are a few of the letters written 50 years ago. Fortunately, some of them did survive and the City is looking for the intended recipients or family members. These include:
