

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROCKPORT, TEXAS THAT:





A RESOLUTION DECLARING COUNCIL MEMBER WARD #3 POSITION VACANT AND APPOINTING A CITIZEN TO SERVE AS COUNCIL MEMBER SINGLE MEMBER WARD #3 TO FILL A LESS THAN ONE-YEAR UNEXPIRED TERM EXPIRING MAY 2003 FOR THE CITY OF ROCKPORT, ARANSAS COUNTY, TEXAS.

WHEREAS, on April 9, 2002 the City Secretary certified in writing that there was no proposition on the ballot, that no person has made a declaration of write-in candidacy, and the candidate for Mayor, Todd W. Pearson, was unopposed for election to office. Subchapter C, Chapter 2, §2.051 of the Election Code authorized the City Council to declare the candidate elected to office and cancel the at-large election. By adoption of Resolution No. 02-06, the City Council declared Todd W. Pearson elected.

WHEREAS, on Tuesday, May 7, 2002, the City Council adopted Resolution No. 02-10, A Resolution and Order of Canvassing the Returns and Declaring the Results of the General Election Held on Saturday, May 4, 2002 for the elected offices of Mayor, City Council Member Wards #2 and #4.

WHEREAS, at said Canvass, Todd W. Pearson, the candidate for mayor was declared elected, Leo Villa, the candidate for Council Member Ward #2 was declared elected and Jerry L. Beattie the candidate for Council Member Ward #4 was declared elected.

WHEREAS, with the election of Council Member Ward #3 Representative being elected Mayor by action taken in adoption of Resolution No. 02-06, the City Council now declares a vacancy. Pursuant to Home Rule Charter § 3.05, the position of Council Member Ward #3 shall be filled by a majority vote of the remaining members, if the remaining term is less than one (1) year.

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ROCKPORT, ARANSAS COUNTY, TEXAS;

Section 1. The City Council has adopted a procedure for appointment of vacancy of single member district Ward #3. Notice of vacancy has been posted at the City Hall bulletin board and published in *The Rockport Pilot* on April 13 and April 20, 2002.

Section 2. Three citizens, Carol Jean Allen, Jerry Glenn Lewis and Linda Marie Yates, from Ward #3 have submitted applications to be considered for the vacancy created from the election of Todd W. Pearson, who was duly elected Council Member in May 2001.

Section 3. The members of the Rockport City Council, Mayor Todd W. Pearson, Council Member Ward #1 George E. Marriott, Council Member Ward #2 Leo Villa, and Council Member Ward #4 Jerry L. Beattie convened in Closed Executive Session to discuss the appointment of a Council Member Ward #3.

Section 4. The Rockport City Council upon reconvening into Open Session, by motion made by Leo Villa and seconded by Jerry L. Beattie and by adoption of Resolution 02-11 appointed Jerry G. Lewis to fill the unexpired Single Member Ward #3.

Section 5. 



WHEREAS, the General and Special Election was called for the May 15, 2004 Uniform Election Date by Resolution No. 04-02; and

WHEREAS, the General Election was called to elect the Mayor of Rockport, City Council Member to represent Ward #2 and City Council Member to represent Ward #4. All candidates were unopposed for election to office. There came to be considered the returns of the election held on the 15th day of May 2004 for the purpose of electing the hereinafter-named officials and appearing from said returns, duly and legally made that there were 16 valid and legal votes cast in Ward #1, 31 valid and legal votes cast in Ward #2, 25 valid and legal votes cast in Ward #3, and 25 valid and legal votes cast in Ward #4

WHEREAS, the Special Election was called to propose twenty amendments for the City's Home Rule Charter to the 5,848 registered voters within the City of Rockport; the registered voters and total votes cast for said May 15, 2004 Election are noted as follows:

Section 1. That said elections were duly called; that notice of said General and Special Elections were given in accordance with the law and that said elections were held in accordance with the law.

Section 2. That said Special Election was submitted to the U.S. Department of Justice pursuant to Section 5 of the Voting Rights Act, 42 U.S.C. 1973c. By letter dated April 22, 2004, the Attorney General did not interpose any objection to the specified changes.

Section 3. Todd W. Pearson, candidate for mayor, who was unopposed in the May 15, 2004 general election, is hereby declared elected to said respective office, subject to the taking of the oath of office as provided by the laws of the State of Texas and the Home Rule Charter of the City of Rockport. A total of 64 valid and legal votes were cast as noted below:




ESTABLISH AN AD VALOREM TAX FREEZE ON THE RESIDENCE
HOMESTEAD OF THE DISABLED OR OF THE ELDERLY OVER THE
AGE OF 65 AS AUTHORIZED BY SUBSECTION (h), SECTION 1-B,
ARTICLE VIII OF THE TEXAS CONSTITUTION; ORDERING THE
CITY SECRETARY TO PRESERVE SAID ELECTION RECORDS IN
HER OFFICE IN A BOOK KEPT FOR THAT PURPOSE.**

WHEREAS, on September 16, 2005 the city secretary received a "Petitioner's Committee Affidavit" pursuant to Home Rule Charter Article VI. "*Initiative, Referendum, and Recall*". The Committee consisted of the following registered voters of the City of Rockport: Delo Caspary, Chairman; Harold H. Picton, Frank Orlando Roland, Jr.; Ralph Martin Morgan; Shirley Marie Kirmse; Carl C. Krueger, Jr.; Mary Louise Allen; Joe Angel Flores, Jr.; Janice Wendell; and Jacqueline W. Shaw; and

WHEREAS, the Petitioner's Committee were notified that the current voter registration list contained 5,922 registered voters as verified by Deputy Voter Registrar Joy Dias and 5% or 297 signatures were needed to validate said Petition; and

WHEREAS, on October 11, 2004 the Committee presented their completed Petition to the city secretary for review and presentation was made to the City Council at the October 26, 2004 Regular meeting for action; and

WHEREAS, at the October 26, 2004 meeting the City Council accepted the report of Petition Sufficiency from the city secretary and in accordance with the general laws and Constitution of the State of Texas, and the Charter of the City, a Special Municipal Election was called and ordered for the Saturday, February 5, 2005 Uniform Election Date by Resolution No. 04-19; and

WHEREAS, that the City Secretary was directed to cause notice to be given of said election by publication in the *Rockport Pilot*, official newspaper of the City of Rockport, Texas, in accordance with the City Charter and State Election Code on January 8 and 15, 2005; and

WHEREAS, that said Special Election was submitted to the U.S. Department of Justice pursuant to Section 5 of the Voting Rights Act, 42 U.S.C. 1973c on December 6, 2004. By letter dated January 18, 2005, the Attorney General did not interpose any objection to the specified changes; and

WHEREAS, Irma Parker, City Secretary, was designated as the Early Voting Clerk, Pat Brown, Administrative Assistant, and Linda Cavazos, Records Clerk, were designated as Deputy Early Voting Clerks. Early voting by personal appearance

was conducted each weekday at the Rockport City Hall, 622 E. Market Street, Rockport, Texas between the hours of 8:00 a.m. and 5:00 p.m. beginning on Wednesday, January 19, 2005 and ending on Tuesday, February 1, 2005; and

WHEREAS, at the beginning of Early Voting on January 19, 2005, the City had a total of 5,702 Registered Voters with the breakdown by Ward shown as follows:

A total of eight hundred fifty-six (856) votes were cast during the Early Voting Period; and

WHEREAS, the polls at the polling place on Election Day were open from seven o'clock (7:00) a.m. to seven o'clock (7:00) p.m. with Ilda Rubalcaba serving as Presiding Judge and Don Durand serving Alternate Presiding Judge, and the clerks of the election as appointed for a single election were: Eleanor Terhovanesian, Phyllis Hediger, and Linda C. Rinche; and

WHEREAS, on said Election Day four hundred sixty-one (461) votes were cast and three (3) mail ballots received and counted.

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ROCKPORT, ARANSAS COUNTY, TEXAS:

RESOLUTION NO. 09-11

A RESOLUTION OF THE CITY OF ROCKPORT DECLARING UNOPPOSED CANDIDATES IN THE MAY 9, 2009 GENERAL CITY ELECTION, ELECTED TO OFFICE; CANCELING THE SATURDAY, MAY 9, 2009 ELECTION; AND FINDING AND DECLARING THAT THE MEETING AT WHICH THIS RESOLUTION IS ADOPTED WAS OPEN TO THE PUBLIC, THAT THE PUBLIC NOTICE OF TIME, PLACE, AND THE SUBJECT MATTER OF THE PUBLIC BUSINESS TO BE CONSIDERED WAS POSTED AS REQUIRED BY LAW, INCLUDING THIS RESOLUTION.

WHEREAS, the General City Election was called for Saturday, May 9, 2009 for the purpose of electing members to the city council; and

WHEREAS, the city secretary has certified in writing that there is no proposition on the ballot, that no person has made a declaration of write-in candidacy, and that each candidate on the ballot is unopposed for election to office; and
